# **DISCLAIMER OF LIABILITY**

## **Golf Cart Use and Operation**

**The Town of Newton Grove ordinance authorizing the use of Golf Carts on public streets and public vehicular areas was adopted to address the interests of public safety. Golf carts are not designed or manufactured to be used on public streets or public vehicular areas, and the Town of Newton Grove in no way advocates or endorses their operation on public streets or public vehicular areas. The Town of Newton Grove, by regulating such operation, is merely trying to address obvious safety issues, and the adoption of this ordinance is not to be relied upon as a determination that operation on public streets or public vehicular areas is safe or advisable, if done in accordance with this ordinance. All persons who operate or ride upon golf carts on public streets or public vehicular areas do so at their own risk and peril, and must be observant of, and attentive to the safety of themselves and others, including their passengers, other motorists, bicyclists, and pedestrians. The Town of Newton Grove has no liability under any theory of liability, and the Town of Newton Grove assumes no liability, for permitting golf carts to be operated on the public streets and public vehicular areas, under special legislation granted by the state's legislature. Any person who operates a golf cart is responsible for procuring liability insurance sufficient to cover the risk involved in using a golf cart on the public streets and public vehicular areas of the town.**
